The Composites Fabricators Association in association with the EPA conducted a study of styrene emissions from open mold composite manufacturing. monomer is a volatile liquid that will react to form a non-volatile copolymer with unsaturated polyester resins. The value to determine is thus the amount of material lost prior to the completion of the reaction. The data gathered in this study is the actual measurement of emissions based on the percent styrene in the coating and the application method chosen. It was shown that the nonatomizing applications (such as brushing or roll coating) emit much less than the atomizing application (spraying). Using the data from this study, a Unified Emissions Factor (UEF) table was prepared.

Dura Technologies, Inc. considers this to be the best available science for calculating the emissions of coatings containing styrene monomer. We will therefore report three distinct VOC numbers. The VOC reported in section III of the MSDS is based on 100% evaporation of the styrene. This attachment will report the VOC calculated using the UEF factors for atomized application and non-atomized application.
